The above mentioned facts are true and correct to the best of my knowledge, information and belief.

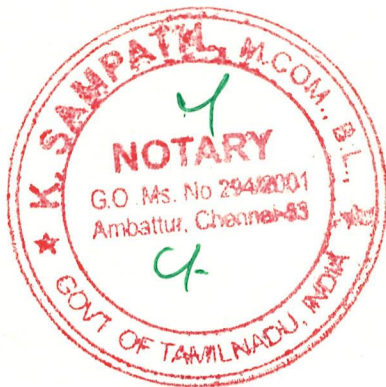
